# Paying your rent

We offer a range of rent payment methods, listed below, that apply to both your house and garage rents. If you struggle to make your regular payments, get in touch with one of our specially trained members of staff.

## By direct debit

- If you have a bank account, this is a simple method.
- You can choose from one of the five dates to pay 2<sup>nd</sup>, 8<sup>th</sup>, 15<sup>th</sup>, 22<sup>nd</sup> or 28<sup>th</sup> of the month.
- With a direct debit you don't have to adjust it or notify the bank of any changes to your rent account we do this for you.
- We will always give you at least 10 working days' notice in writing of any change to the amount you have to pay, and you are protected by the Direct Debit guarantee;
- All you have to do is ensure enough money is in your account on the requested payment date. If your payment date falls on a weekend or bank holiday, the payment will take from your account the next working day.

## Online

- By credit or debit card at any time.
- Visit www.lincoln.gov.uk/pay-for-it and select 'pay your housing rent'
- You will need your rent reference number to do this. You can find this in your tenancy agreement or on rent statements we send you.

## Automated telephone payment

- Payments can be made 24 hours a day, seven days a week and 52 weeks a year.
- will need a touchtone telephone, your rent account reference number and a debit or credit card.

Just call the automated payment line on 01522 873666 and you will be led through a series of simple prompts. When paying use \* in place of the / when inputting your rent reference. For example: 00000000\*01 instead of 0000000/01. The call will prompt you to do this.

Calls are charged at a local rate and your rent account will be credited in two to three working days.

## By standing order

- You can set up a standing order with your bank to pay rent to us.
- This would be at an amount, frequency, and date of your choosing\*
- You will have to amend the order yourself with your bank for any increase/decrease to payments or changes to the frequency or date of payments.
- To set up a standing order you will need our bank details below:

Bank account: City of Lincoln Council Sort code: 30-95-05 Account number: 00214663 Payment reference: Your rent reference number

\*You must ensure your standing order is enough to cover your rent. If in doubt speak to customer services or your housing officer to see how much you need to pay.

## At a bank

- By cash or cheque but you may have to pay a fee to the bank
- You may pay cash or cheque at any bank by completing a bank form but please make sure you quote the following details: -

## At a "PayPoint" facility

- You can pay your rent at any outlet displaying the "PayPoint" sign;
- You can pay by cash, but you will need to show a rent payment card;
- You will not be charged a fee for using this card.

#### **Rent payment card request**

If you are unable to pay by any of the above methods, contact customer services to discuss the possibility of a rent payment card.

## Your security

All web and automated telephone payment line transactions are dealt with by third party payment providers who are fully compliant with all requirements to keep your card details safe and secure. Your safety and security in making all types of payment is our utmost priority and we are fully compliant with all standards to ensure this is upheld.

## Get in touch

If you're having difficulty paying your rent then help us to help you; contact customer services, or your housing officer immediately. We can help you sort out your rent account before the arrears get out of control.

If you have already arranged to repay arrears and your circumstances change so that you are unable to keep up with that arrangement, contact us immediately.

Above all keep in touch so that we can help; don't stop paying.
