Crematorium and Cemeteries

Benefits

Universal Credit

You can apply for Universal Credit at https://www.gov.uk/apply-universal-credit

If you are unable to apply online you can call Citizens Advice on 0800 1448 444 and they will assist to make your claim.

Council Tax Reduction

You can apply for Council Tax Reduction at www.lincoln.gov.uk/apply

Please note you will not be entitled to Council Tax Reduction if you are working age and have more than £8,000 in capital. If you are of pension age you can have capital up to £16,000 (excluding the property you live in)

Housing Benefit

You can apply for Housing Benefit at www.lincoln.gov.uk/apply

Please note you can only make a new claim for Housing Benefit if:

- You are State Pension Credit age, if you are a couple you both need to be State Pension Credit Age (currently this is anyone born before 01/07/1954), or;
- You live in Specified Accommodation or Temporary Accommodation, you will still need to claim Universal Credit for your living costs, or;
- You are receiving Severe Disability Premium;
- You will not be entitled to Housing Benefit if you have capital of over £16,000.

Discretionary Housing Payment

If you receive Universal Credit Housing Costs or Housing Benefit and your rent is higher than the contribution from either, you can apply for Discretionary Housing Payment https://www.lincoln.gov.uk/housing-council-tax/apply-discretionary-housing-payment

Discretionary Rental Hardship Payment Fund



Waste

Collections



Through our partnership with Biffa we are striving to maintain waste collection services as scheduled. Please continue to present all waste for collection by 7am on the day of collection.

Please wear gloves or clean your bin handles before and after collections to avoid potential coronavirus contamination. If you are self-isolating please ensure all used tissues are double-bagged and stored for 72 hours prior to your general collection.

Please ensure all cars are parked to allow 2.9m of gap to permit the waste wagon to pass safely or your collection may not be possible.

Any future changes to the waste service will be widely publicised using the city council website, social media channels and the local media.

We hope to be in a position to announce renewals and new subscriptions for the 2020/21 garden waste service shortly. The service year runs 1st July for one year.

Assisted Bulky Waste Collections

Unfortunately, this service has had to stop and bookings can no longer be made until further notice. We are keeping this under review and will restart the service as soon as possible.

Street Cleansing

We will continue to provide street cleansing, litter bin and litter picking services, although the number of litter pickers on foot may be reduced throughout the city. We will continue to deploy mechanical sweepers to the normal schedules.

Household Waste Recycling Centres (the waste tips)

Lincolnshire County Council has announced all recycling centres are closed until further notice. Please keep your waste at home until they reopen. A phased reopening is anticipated and this will be widely publicised when it happens.

Businesses

Following the announcements by government on business rate relief we are working through ongoing government guidance as to how this operates. More information can be found at www.lincoln.gov.uk/support

You will have been sent a business rate bill previously which will be replaced in due course if you are entitled to this relief.

In the meantime, we will be proactively cancelling business rate direct debit payments due in April 2020 for all businesses likely to fall into the categories entitled to relief.

Packages for business

The government has set out a package of measures to support public services, people and businesses through this period of disruption caused by Covid-19.

This consists of a £330 billion package of measures to support businesses, including:

- A Coronavirus Job Retention Scheme
- Deferral of VAT and Income Tax payments
- A Statutory Sick Pay relief package for small and medium sized businesses
- A 12-month business rates holiday for all retail, hospitality, leisure and nursery businesses in England, which has been extended to include estate agents, lettings agents and bingo halls
- Small business grant funding of £10,000 for all businesses in receipt of small business rate relief or rural rate relief
- Grant funding of £25,000 for retail, hospitality and leisure businesses with property with a rateable value of between £15,000 and £51,000
- A Coronavirus Business Interruption Loan Scheme offering loans of up to £5 million for SMEs through the British Business Bank

- A new lending facility from the Bank of England to support liquidity among larger firms, helping them bridge coronavirus disruption to their cash flows through loans
- The HMRC Time to Pay Scheme
- A scheme to assist those who are self-employed.

Small Businesses, Retail, Hospitality and Leisure Businesses

If a business had registered for businesses rates by 11 March 2020, and their property was occupied and either in receipt of small businesses rate relief, rural rate relief or classified as retail, leisure or hospitality on that day then we have been able to assist in the following ways:

- We are delivering a £10,000 cash grant to our smallest businesses
- Small businesses that pay little or no business rates and are eligible for small business rate relief (SBRR) or rural rate relief have been contacted about this grant
- We have also awarded a £25,000 cash grant to retail, hospitality and leisure businesses
- This £25,000 grant has been awarded to retail, hospitality and leisure businesses operating from smaller premises, with a rateable value between £15,000 and £51,000.

We have written to all businesses that we believe are eligible for either the small business or retail, hospitality and leisure grant.

If you have not heard from the council but believe you are eligible for a grant, please contact us at supportingbusiness@lincoln.gov.uk in the first instance, attaching a copy of your business rates bill.
